

RAD Diversified-REIT Scholarship Awards Program

Overview: RAD Diversified REIT, Inc. is announcing its launch of the RAD Diversified REIT Scholarship Award. The RAD Diversified REIT (RADD) Scholarship Award is designed to assist RADD employees, their families, and the RADD Inner Circle with tuition assistance and other required funds to further their education and development at an educational institution and will be awarded yearly. Educational institutions include a public or private community college, college, university, or vocational school that has both academic faculties and a student body. A RADD Scholarship may also be awarded to a candidate in professional certification programs such as Project Management Professional (PMP), Lean Six Sigma Certifications, or similar designations. RADD CEO and Co-Founder will determine on a yearly basis the aggregate dollar amount that will be allocated to the RADD Scholarship Awards. The maximum amount of a RADD Scholarship Award for an awardee will be \$5,000 each qualifying academic year. This maximum award to an individual awardee, however, may be increased upon the recommendation of the RADD Scholarship Award Committee and approved by RADD's Executive Staff composed of RADD's CEO, Co-Founder, COO and V.P. of Real Estate.

Eligibility: RADD employees having worked for a minimum of one year with RADD, their immediate family members, to include spouse, and children (natural, stepchildren, adopted, and fostered) are eligible. Children must be under the age of 26 and continue to receive primary support from RADD parents. Inner Circle (IC) members having been a member for a minimum of 12 months and be in a joint venture partnership with RADD, their immediate family members, to include spouse, and children (natural, stepchildren, adopted and fostered) are eligible for the RADD Scholarship Award. Potential scholarship awardees may submit an application every year as long as they meet eligibility requirements (e.g. an incoming college freshman may submit each year while attending college). Previous awardees of a RADD Scholarship Award are not precluded from submitting an application the following year.

Process: RADD Scholarship Award submissions must be submitted to the Scholarship Coordinator from 01 January to 01 March each year. The submissions will be reviewed by the RADD Scholarship Award Committee for proper validation and prioritized for award purposes. The committee will review and vote on priority and amount of recommended award. Once reviewed and prioritized by the committee, the recommendations will be provided to the Executive Staff (CEO, Co-Founder, COO, and VP of Real Estate). The RADD Scholarship Award Coordinator will formally submit and provide an overview to the Senior Executive Staff. All historical records of RADD Scholarship Award submissions, approvals, awards, etc. will be maintained and readily available for review by the RADD Scholarship Award Coordinator. **Committee**: The RADD Scholarship Award Coordinator. **Committee**: The RADD Scholarship Award Committee Coordinator is Brent Mendenhall at brent@raddiversified.com, (919) 604-5703. This is a non-voting continuous appointment until a successor is appointed by the Chief Operating Officer. Voting members on the committee will consist of the following:

Each RADD employee selected for the RADD Scholarship Award Committee must have at least one year of employment with RADD and be nominated (validated by Paylocity or through email correspondence) by Human Resources. IC Committee member must be in good standing with RADD and have at least one year of investment and one current or past joint venture investment. IC members may contact the RADD Scholarship Award Coordinator to nominate themselves as a



member of the Committee. Status as an IC member must be validated in writing/email through Investor Relations

Approval Process: Potential RADD Scholarship Award awardees must submit a complete application/packet (see Appendix A-E) to brent@raddiversified.com no later than 01 March in the application year. This will be for the upcoming calendar year scholarship award (normally for the start of the calendar year school schedule in May/June of said year). The Committee will meet between 01 March – 15 March to review and vote on the submitted applications. Awardees will be selected on an objective and nondiscriminatory basis. Criteria for approval may include, but is not limited to, financial capacity/need of submitter (family, etc.), prior academic performance, proposed area of study, past or current community involvement, and academic extracurricular activities (sports, arts, clubs, etc.). The Committee Coordinator will schedule a presentation of applications along with Committee recommendations with RADD's Executive Staff no later than one week after the conclusion of the Committee meeting on the application packets. On 01 April, all RADD Scholarship Award recipients will be announced. This shall be a formal company-wide presentation and celebration recognizing and congratulating the RADD Scholarship Awardees.

The RADD Scholarship Award Committee have many essays to review. Setting the general format for all submissions saves them time when reading essays and allows for a more objective review and evaluation of submissions. Essays should have the following general formatting guidelines:

- a. Double Spaced
- b. 12 or 13-Point Font, Times New Roman or Arial
- c. 1-1.5" margins (top, bottom, side)
- d. 300-500 words, not to exceed one page
- e. Last name, first name in top left of essay
- f. Titles are optional. Remember, titles catch the audience and is the first thing a reader may see.
